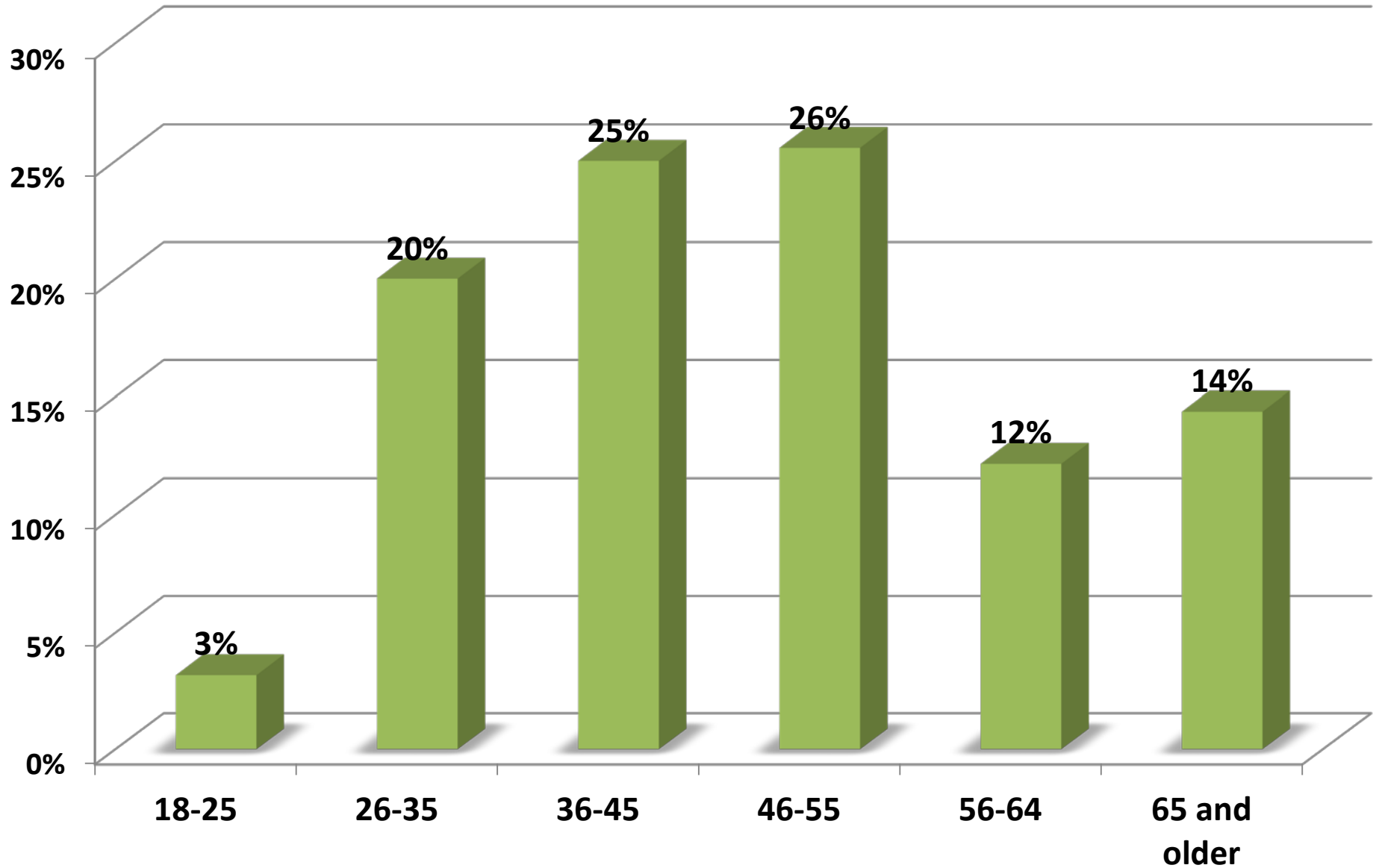

Survey Summary

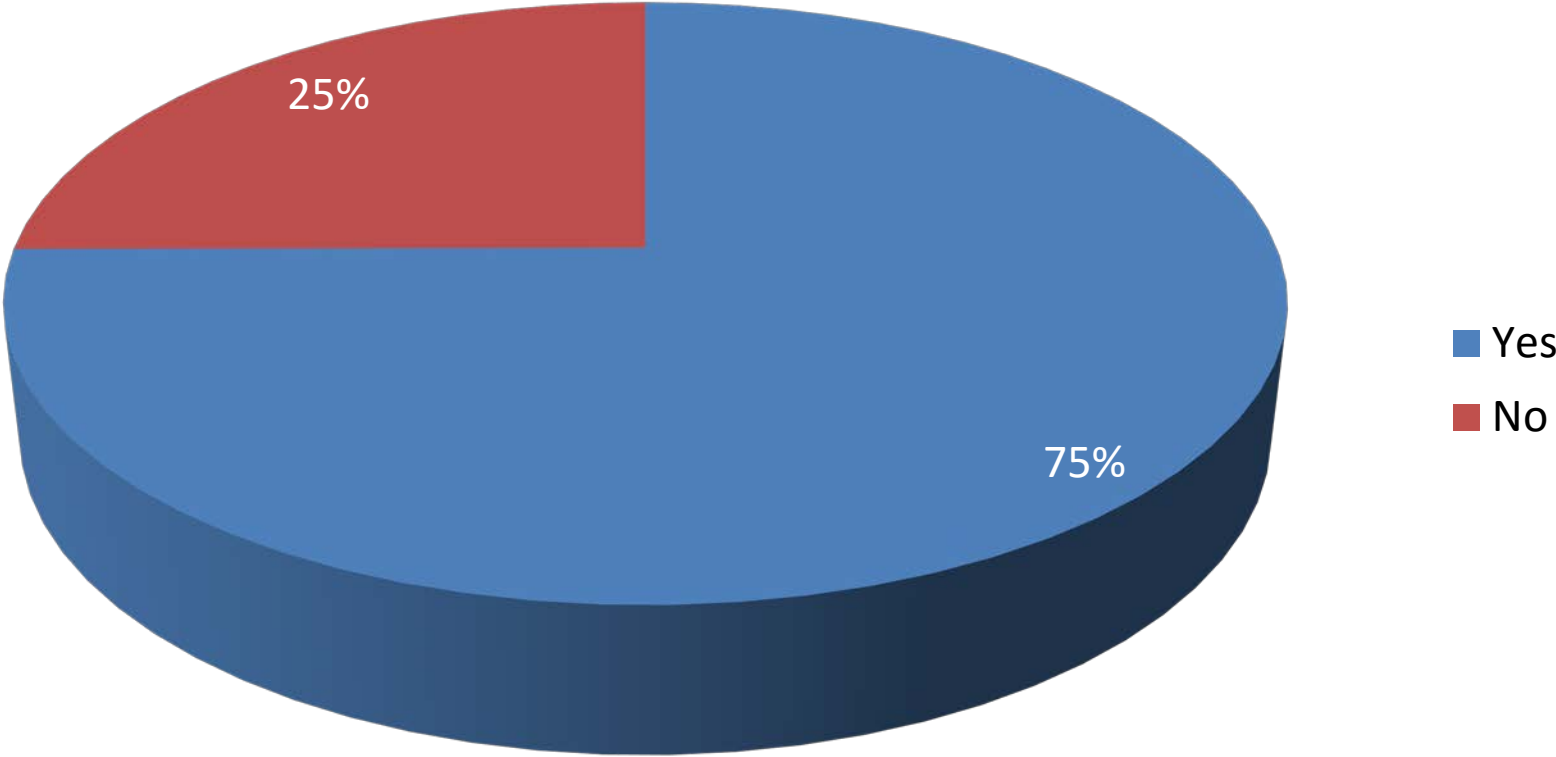
- The community survey was conducted in late November/early December of 2016.

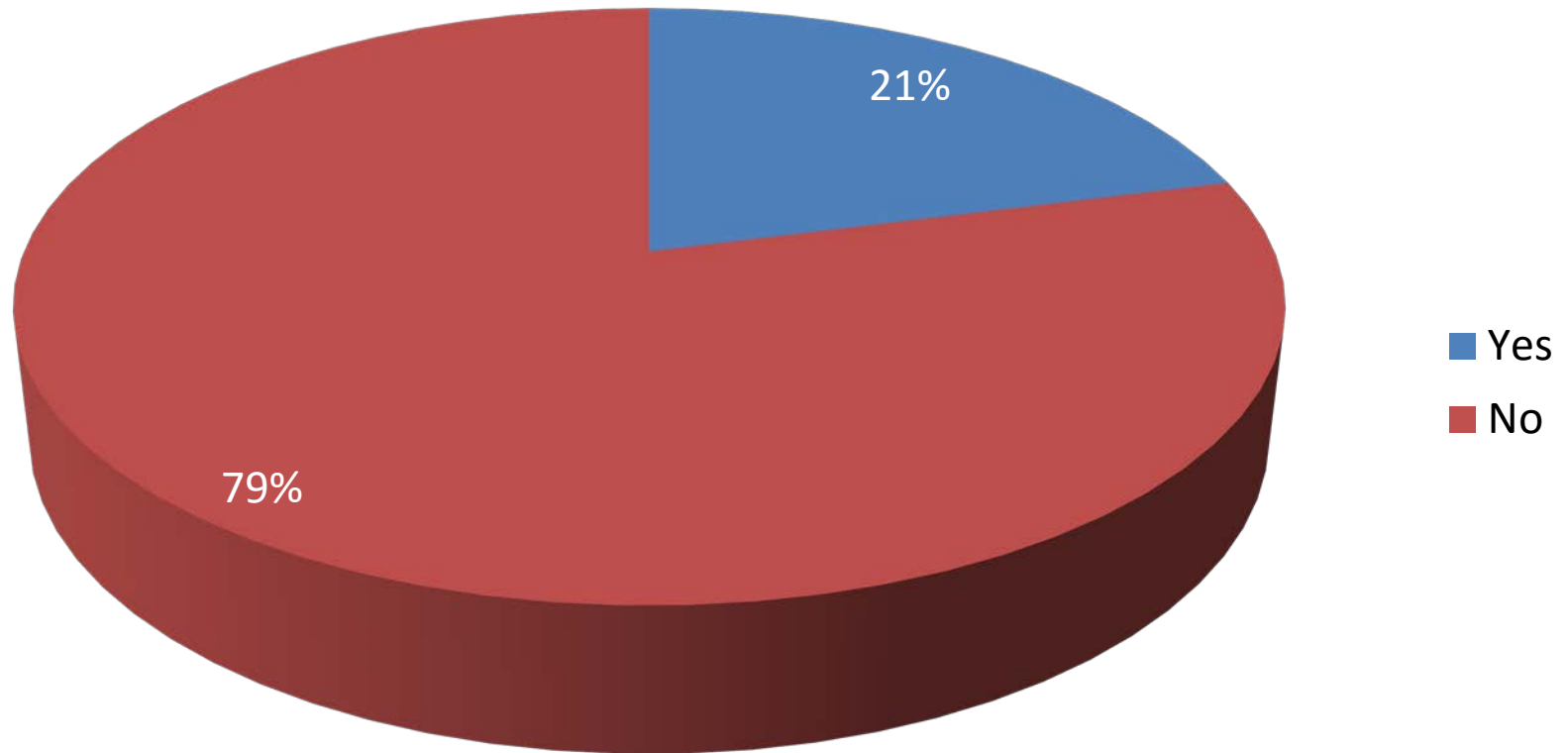
What is your age?



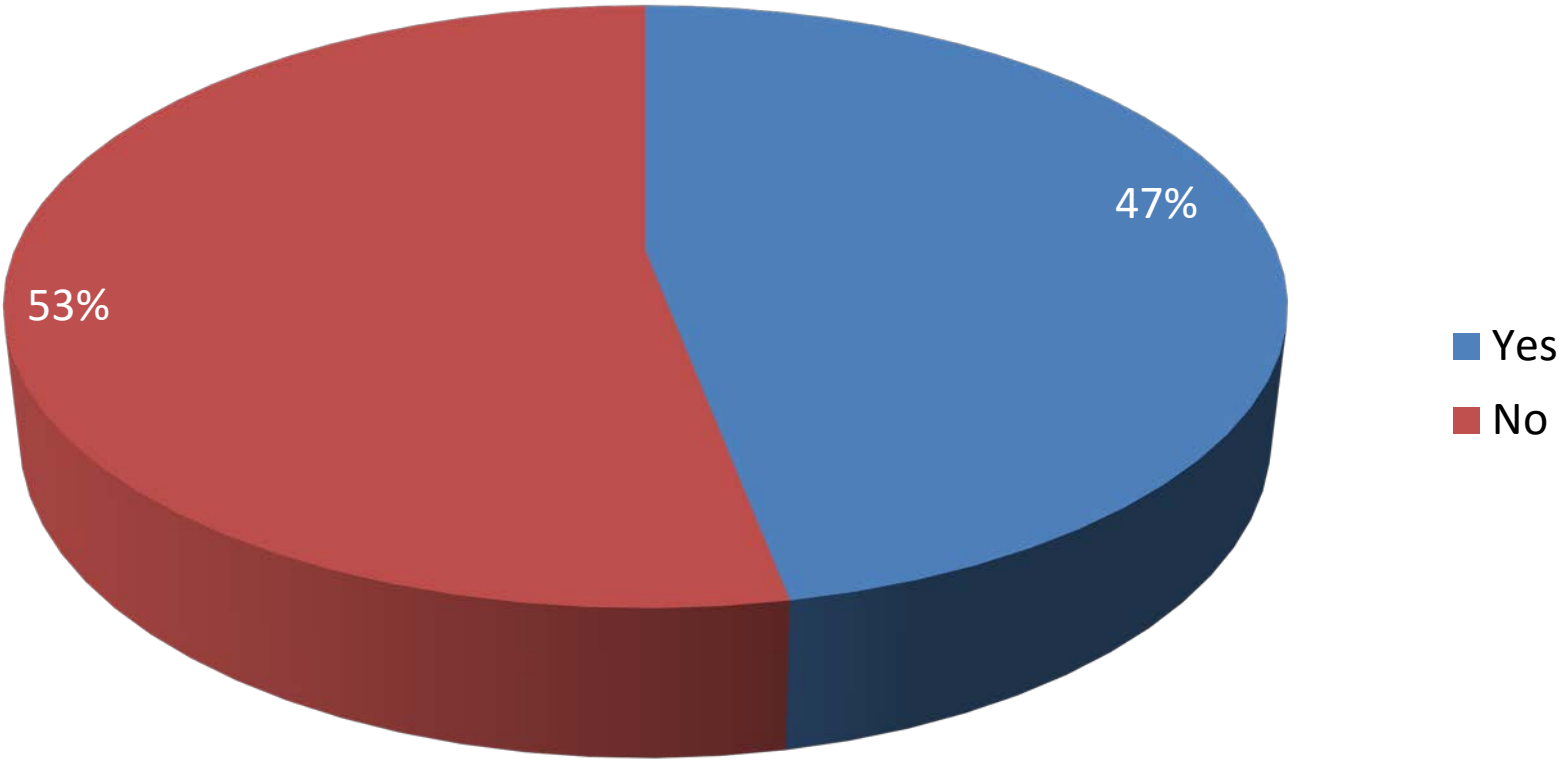
Do you live in the Little Chute Area School District?



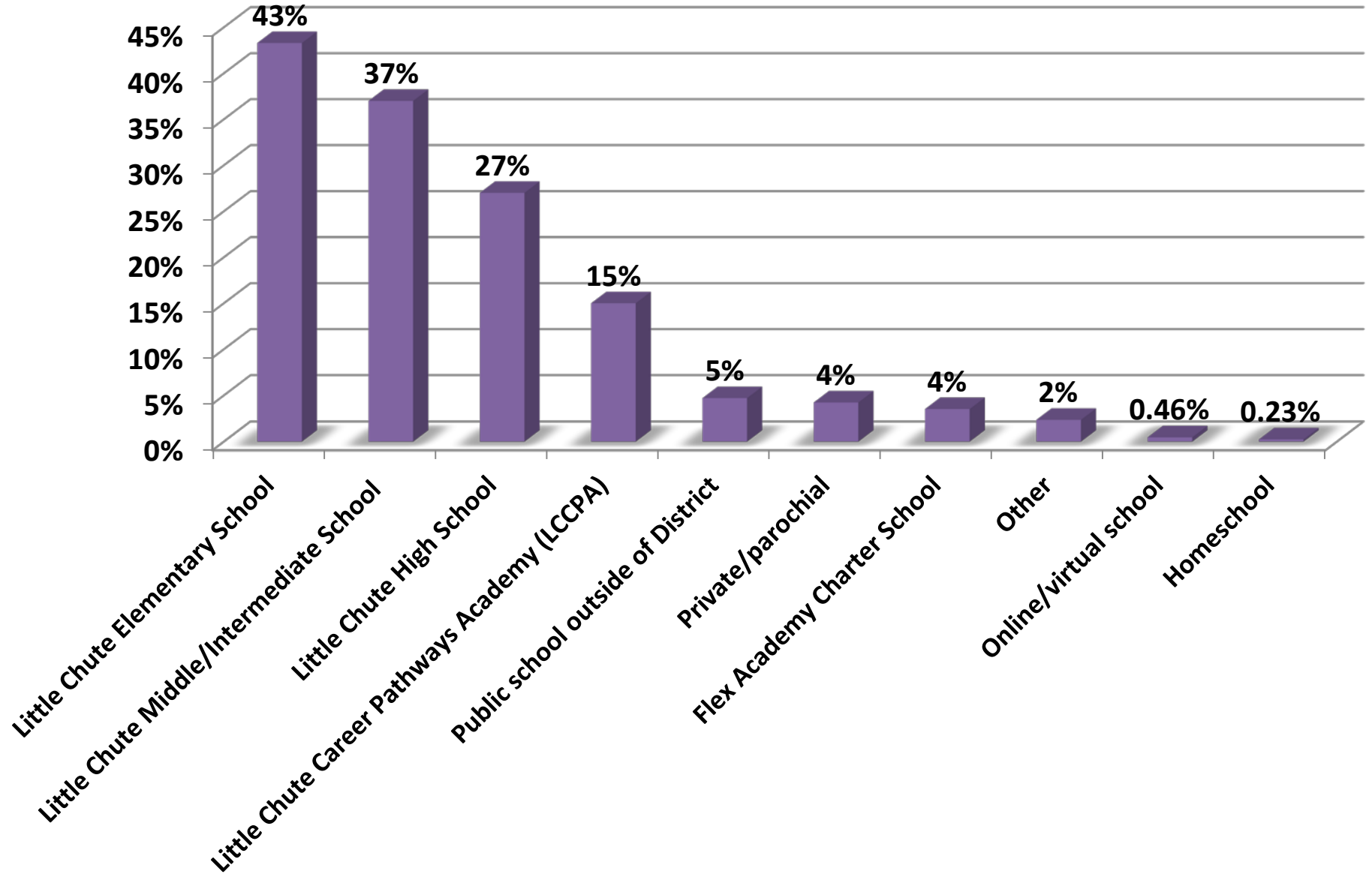
Are you an employee of the Little Chute Area School District?



Do you have children attending our schools?

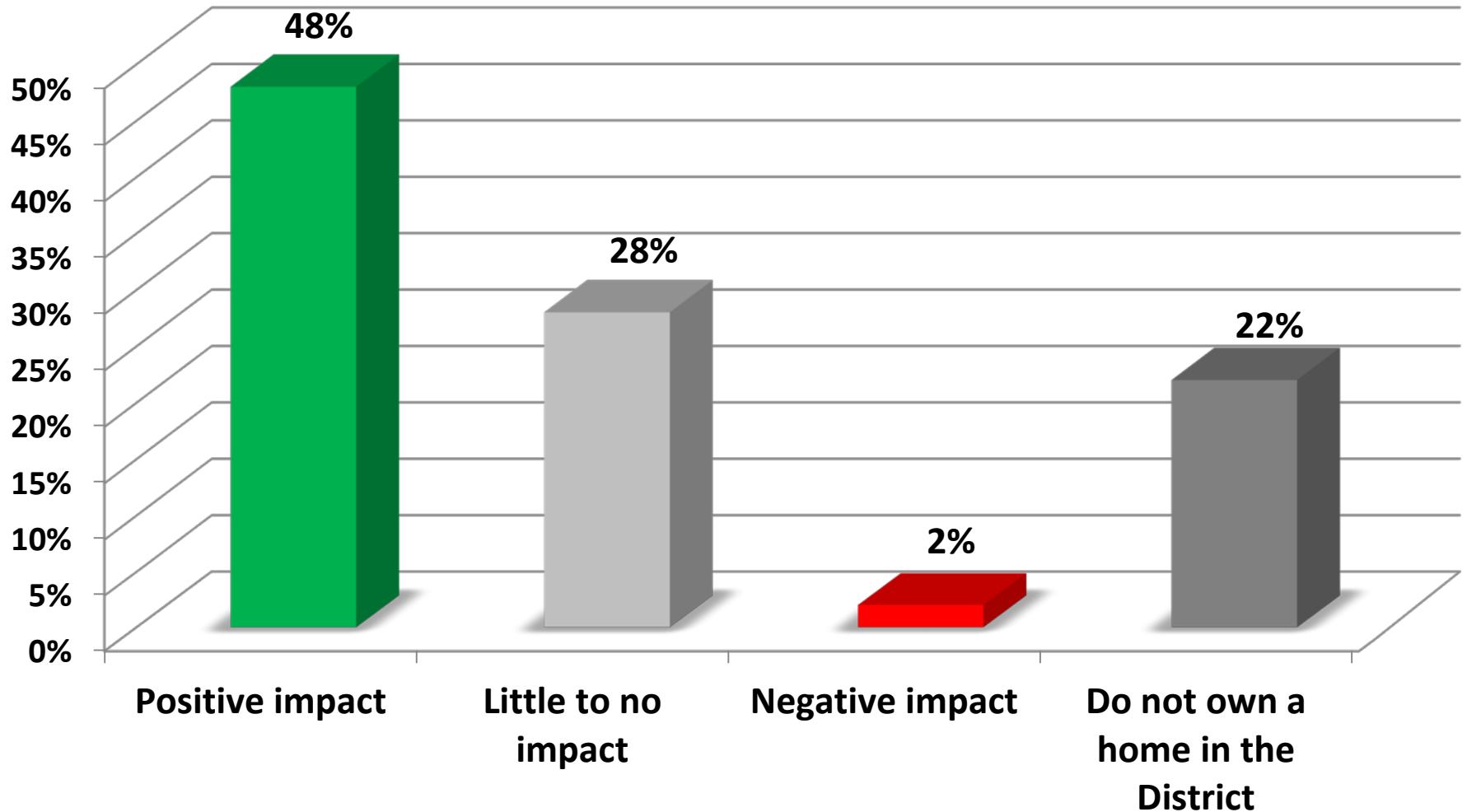


If you have school-aged children, what school(s) do they attend?

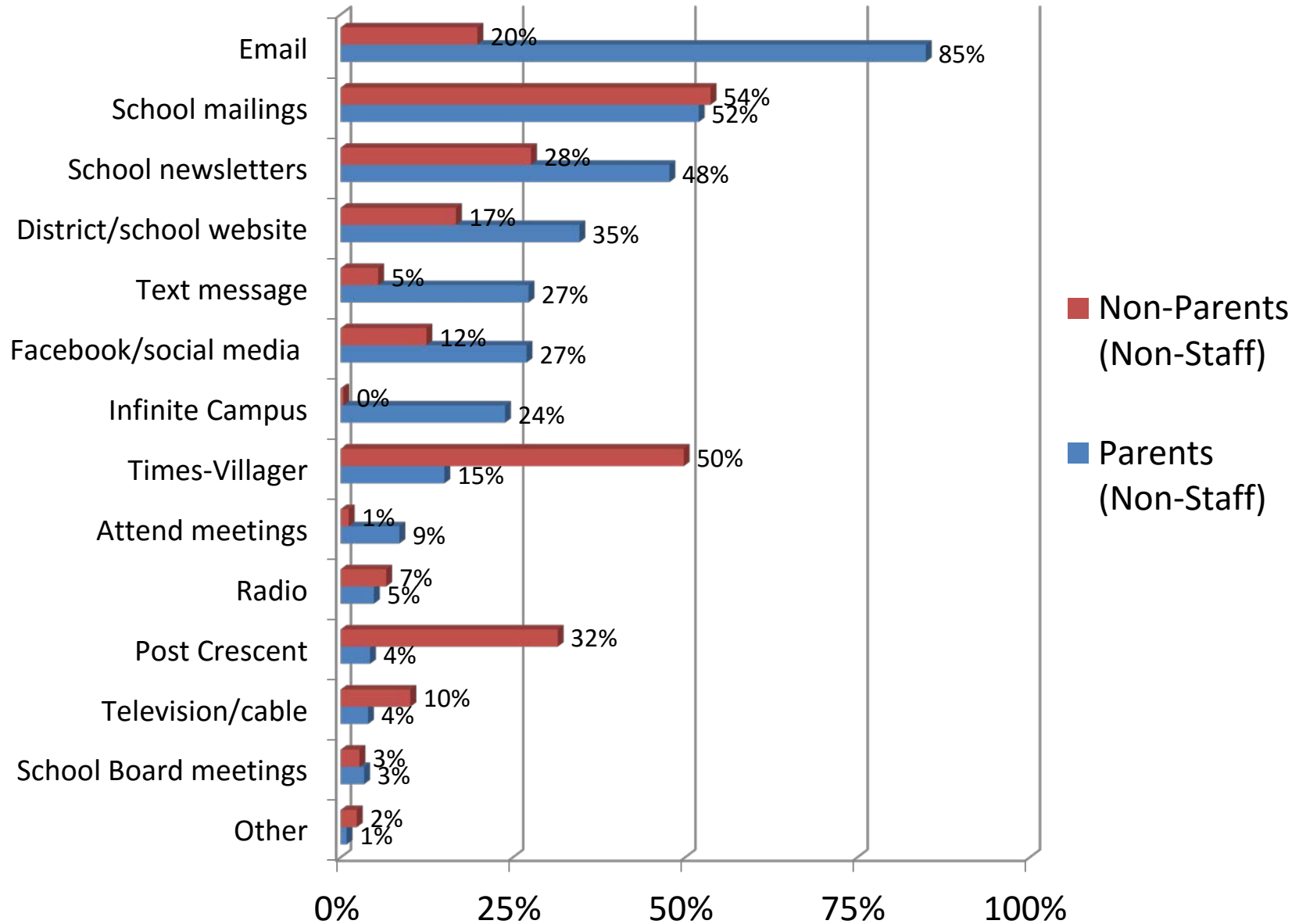


Overall, what impact do you feel the Little Chute Area School District is having on your home value?

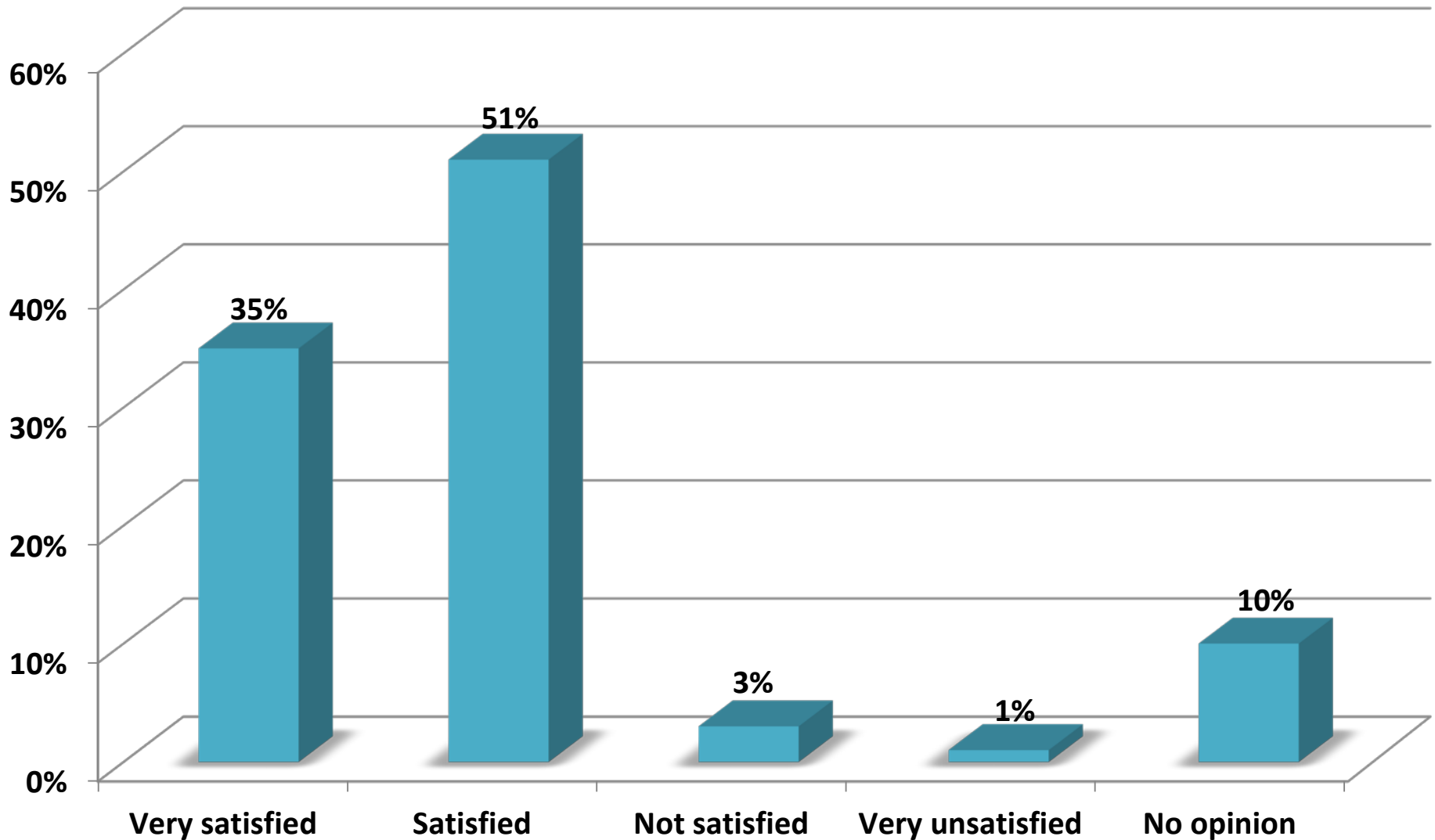

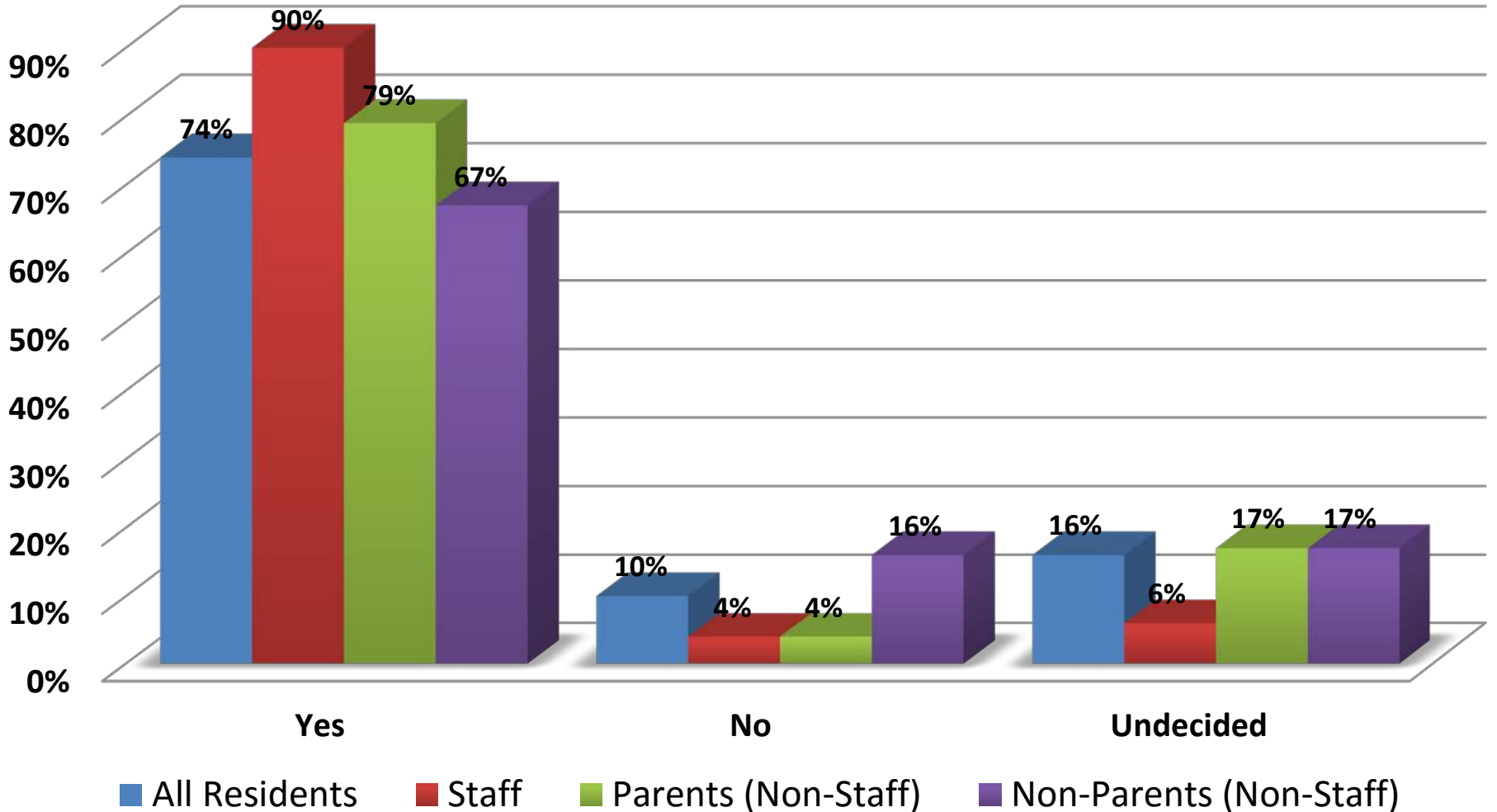


Funding to Support Technology

Representing an estimated annual tax increase of \$5 for each \$100,000 of property value over the current level.

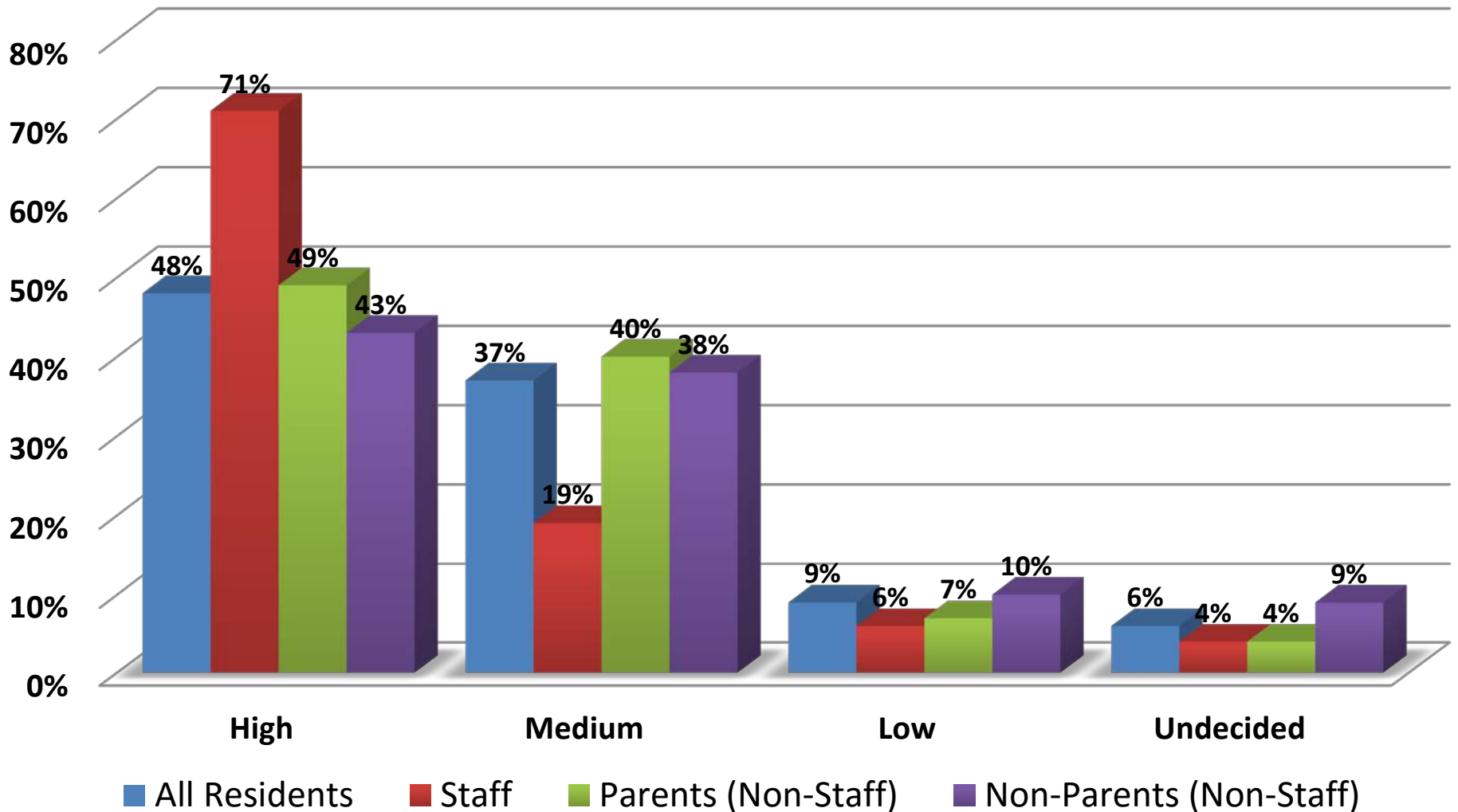

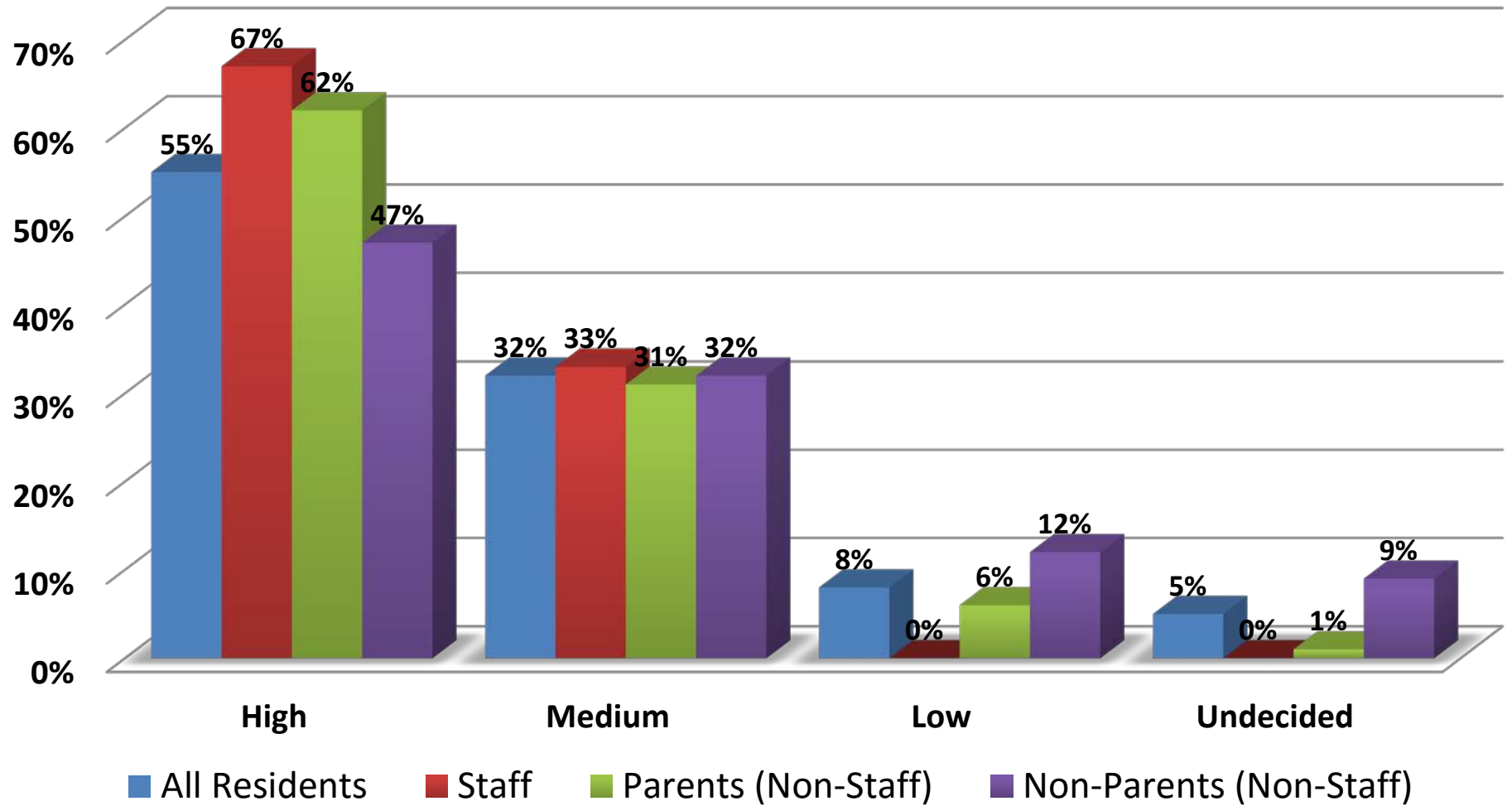
What priority would you place on updating building infrastructure?

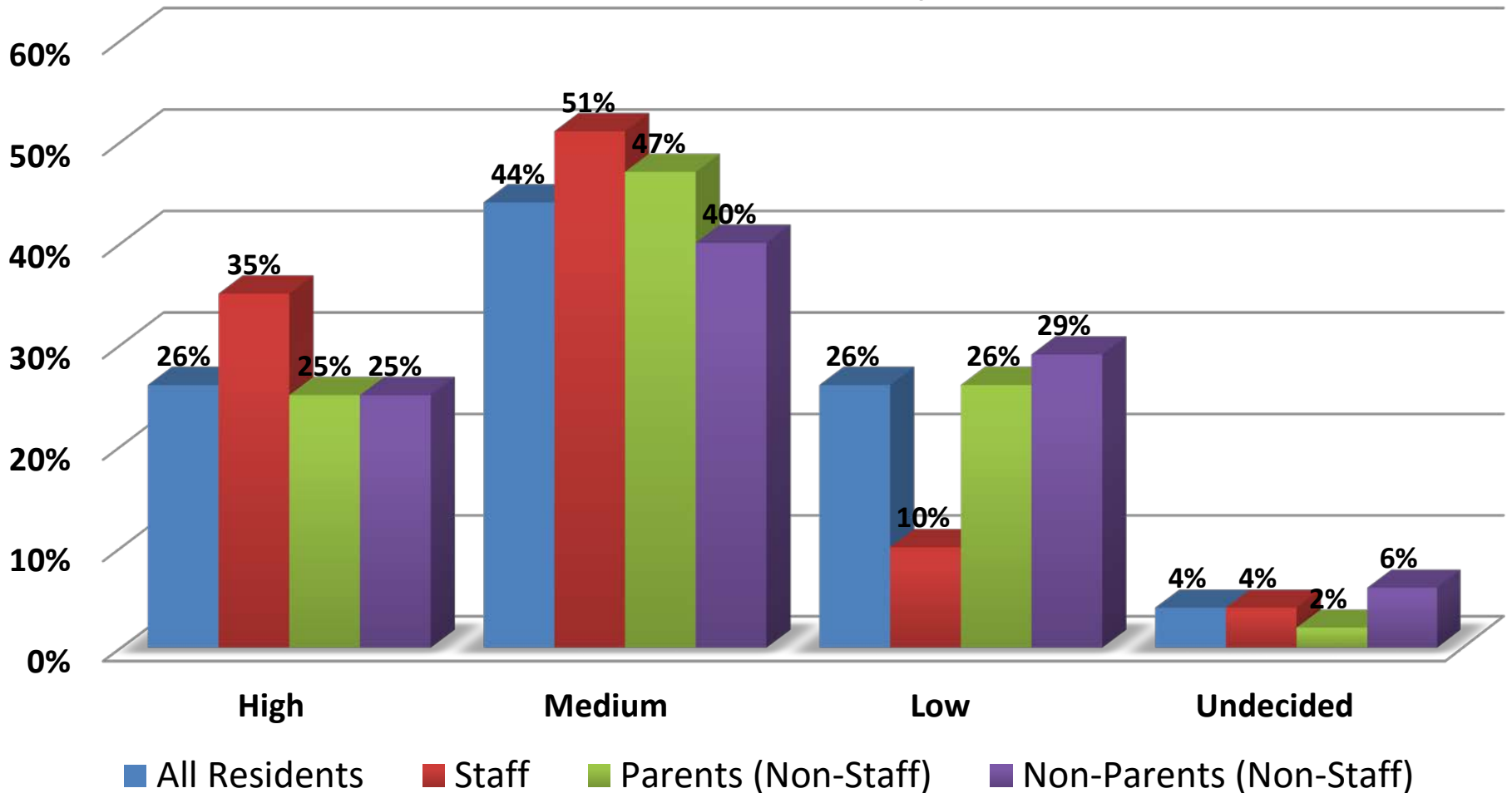
What priority would you place on renovating space to create middle/high school science, technology engineering and math classrooms?

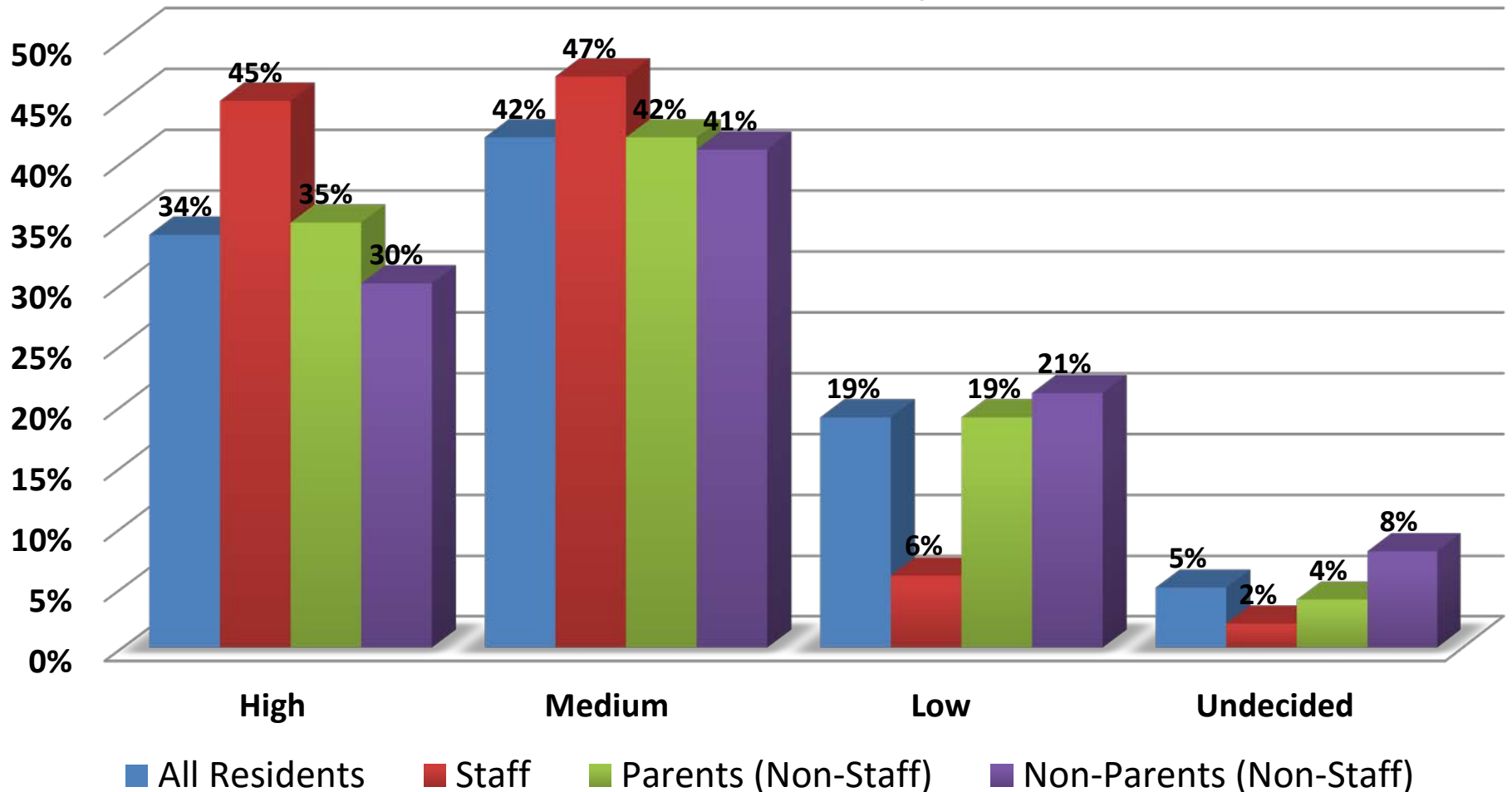
What priority would you place on expanding the school's kitchen and renovating the cafeteria?

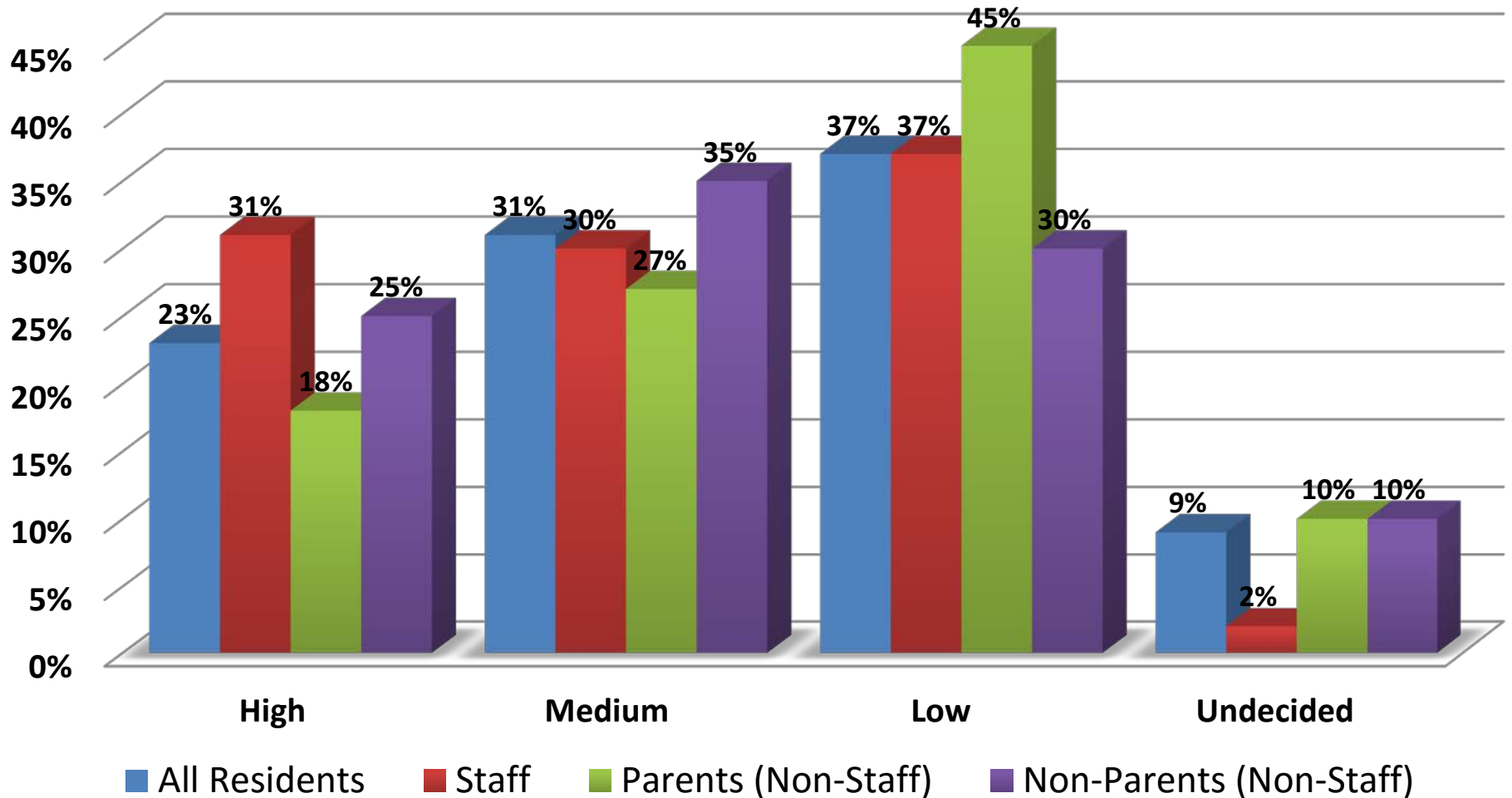
What priority would you place on combining the schools' library media centers?

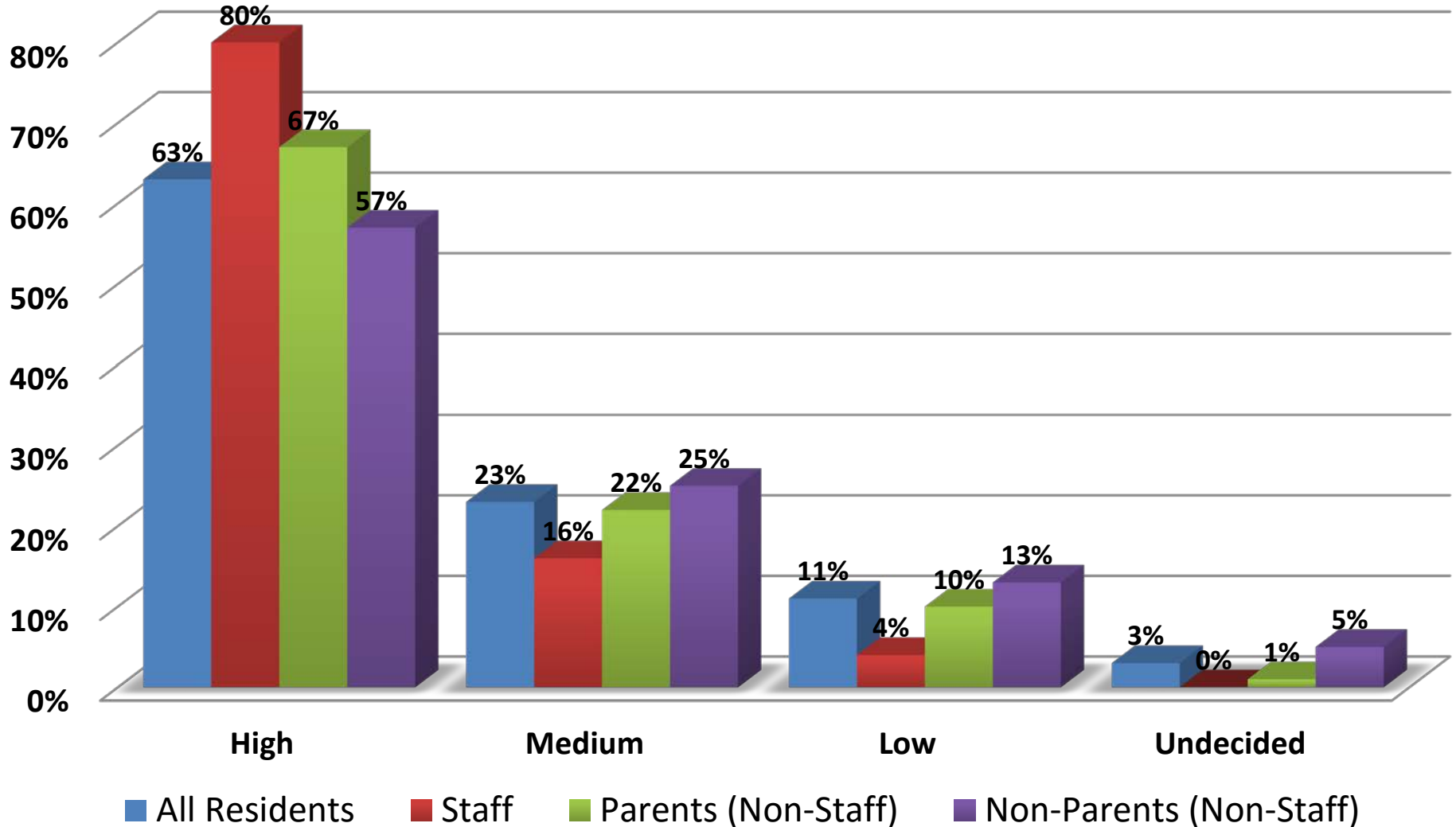
What priority would you place on renovating space to move the Flex Academy to the Intermediate/Middle/High School campus?

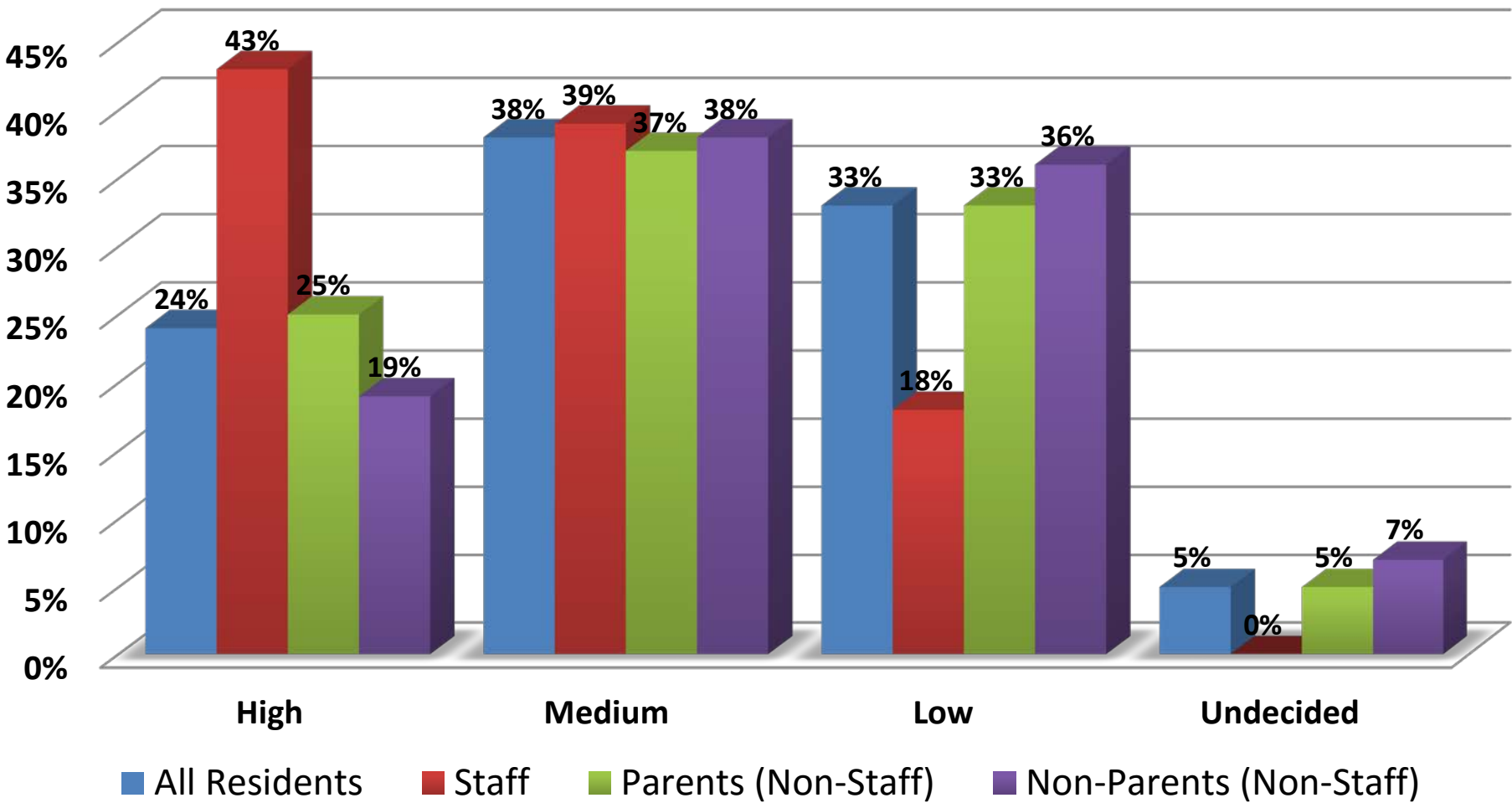

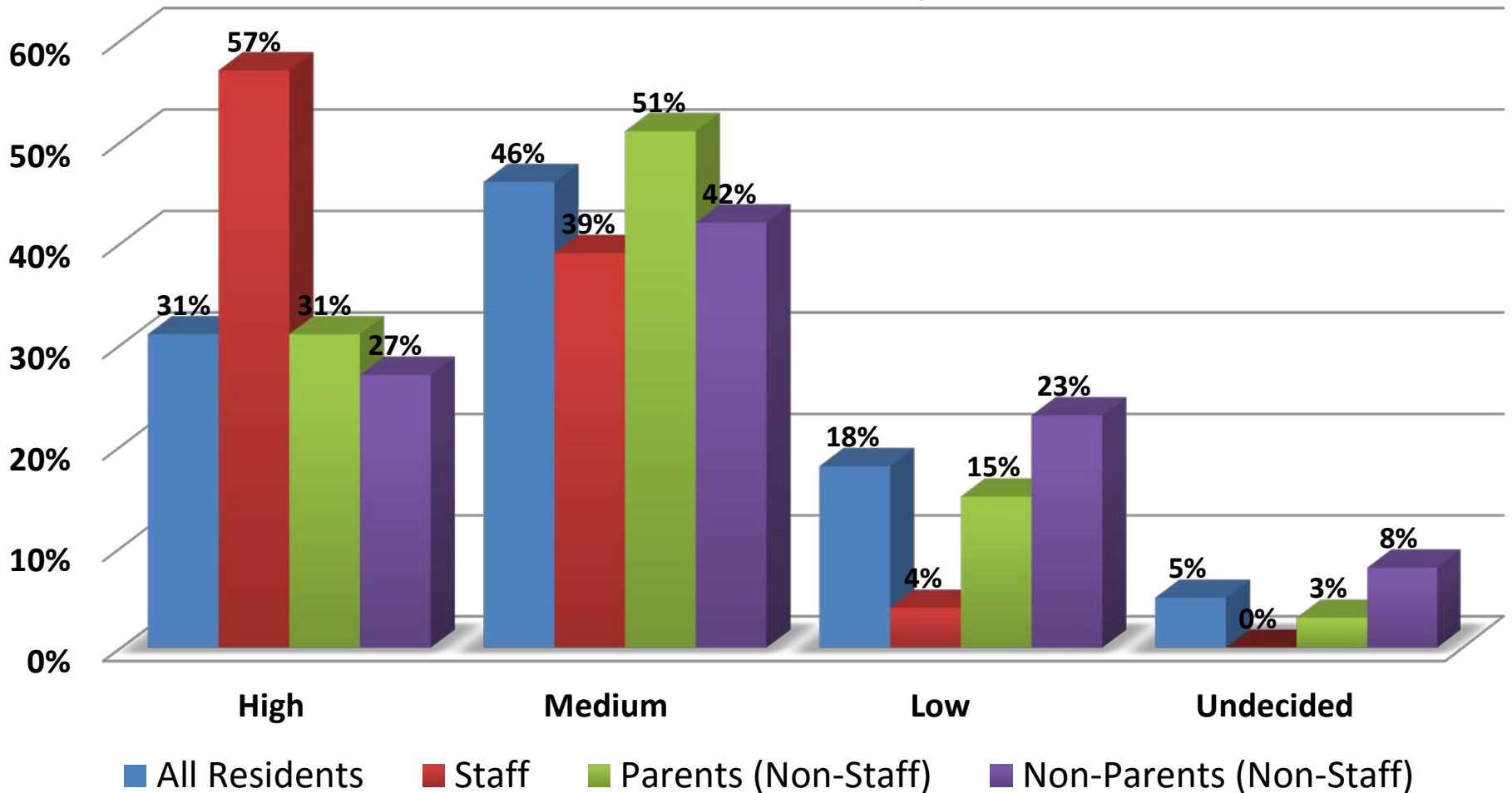
What priority would you place on updating the school and community weight room and fitness center?

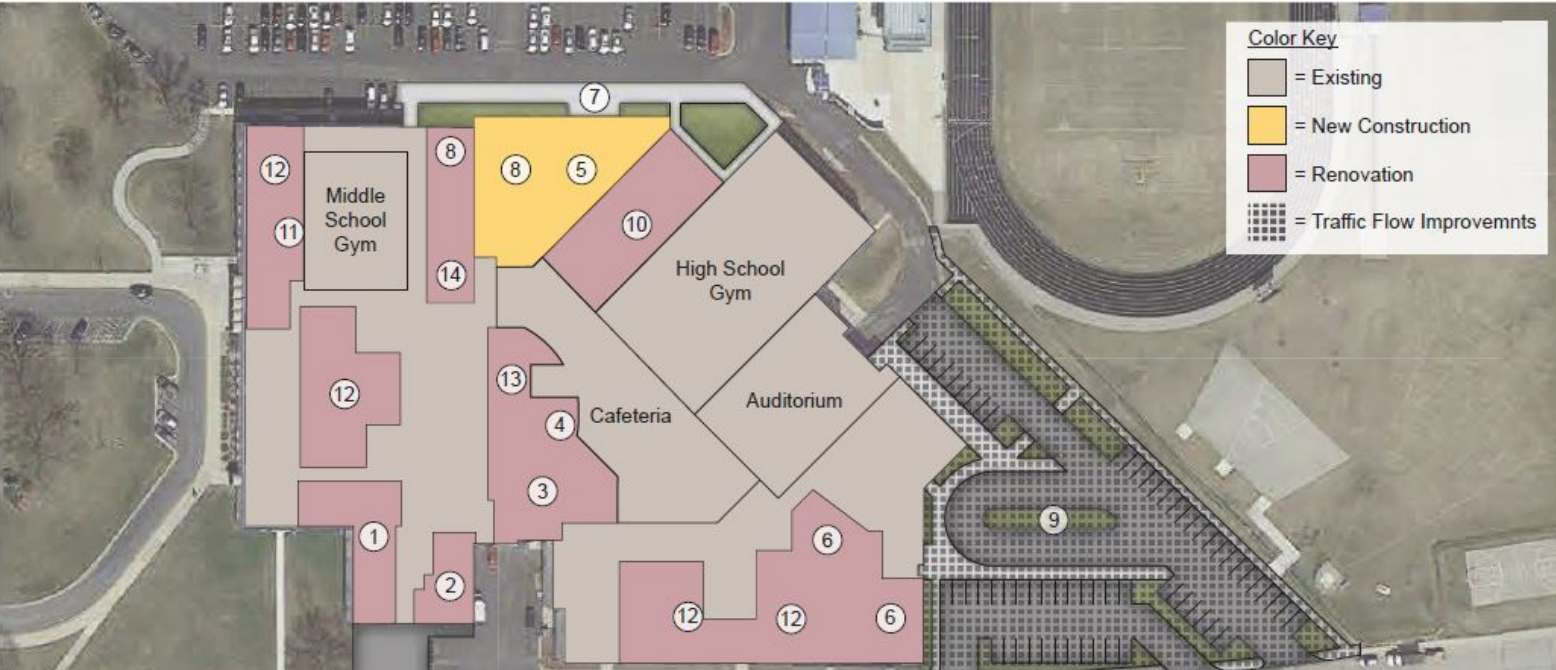

This plan addresses the infrastructure, safety and educational needs outlined on the previous pages. The total cost for this project is estimated at \$19.4 million. In order to make this investment, a referendum would need to be approved by voters.

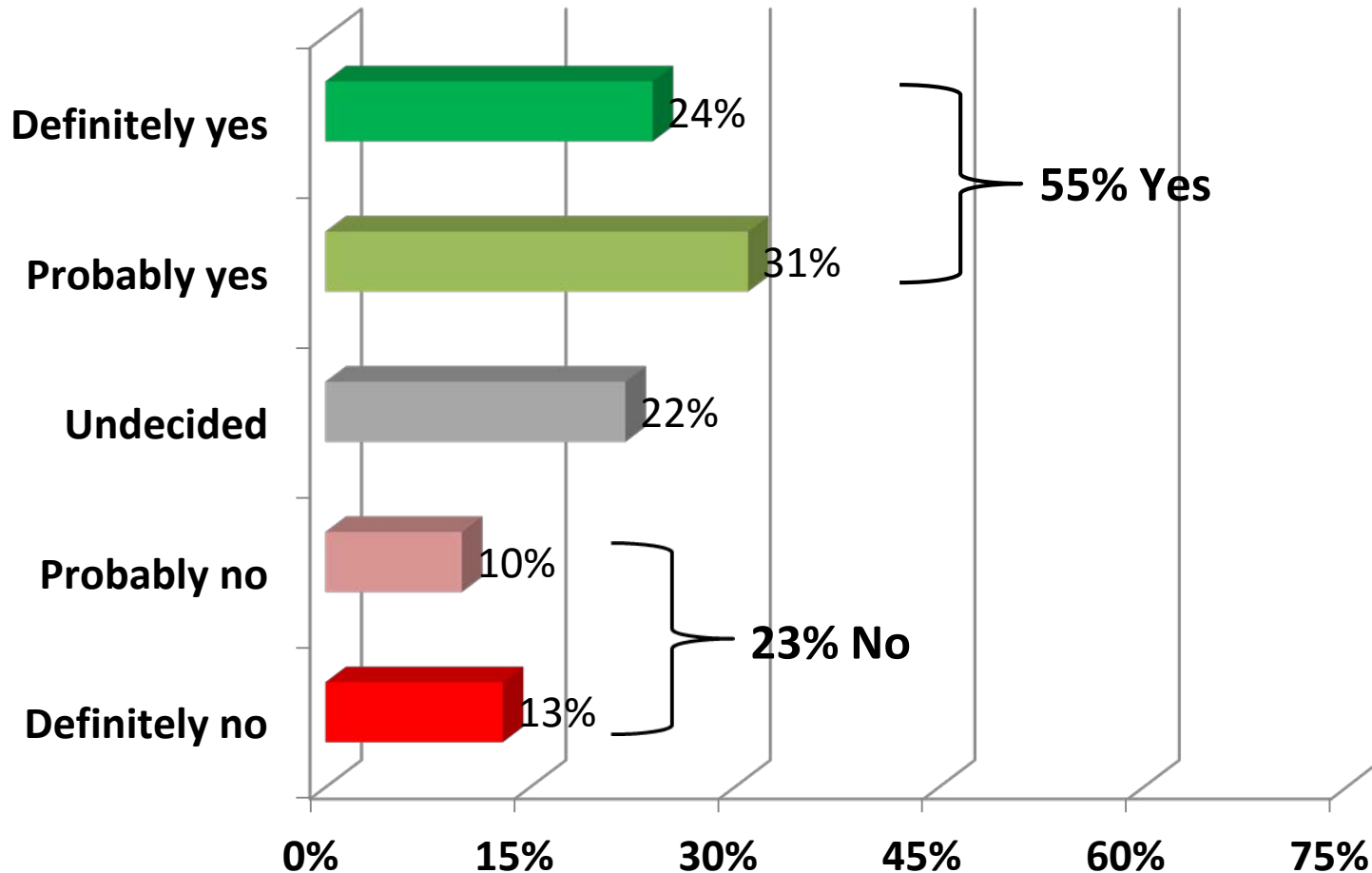

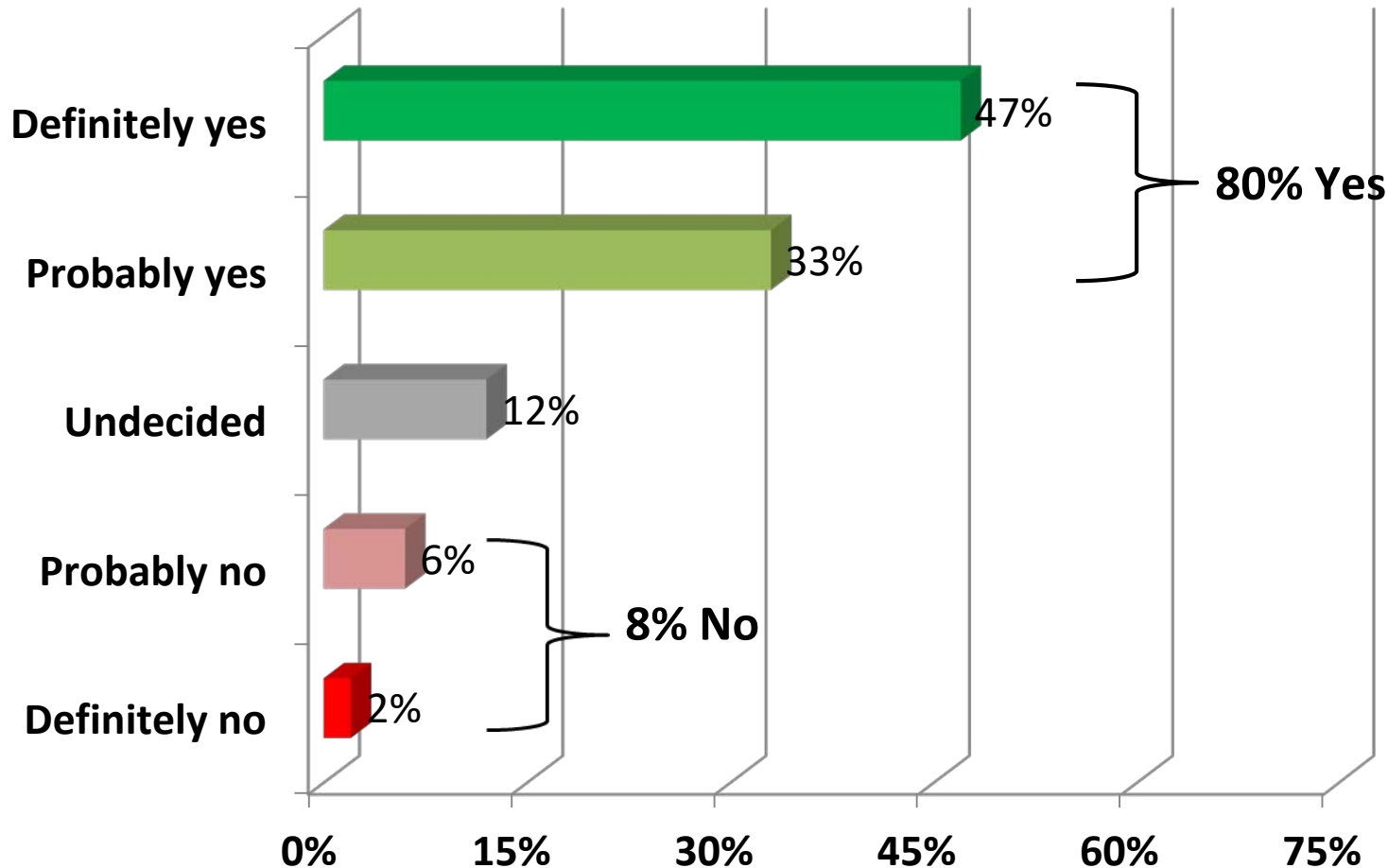

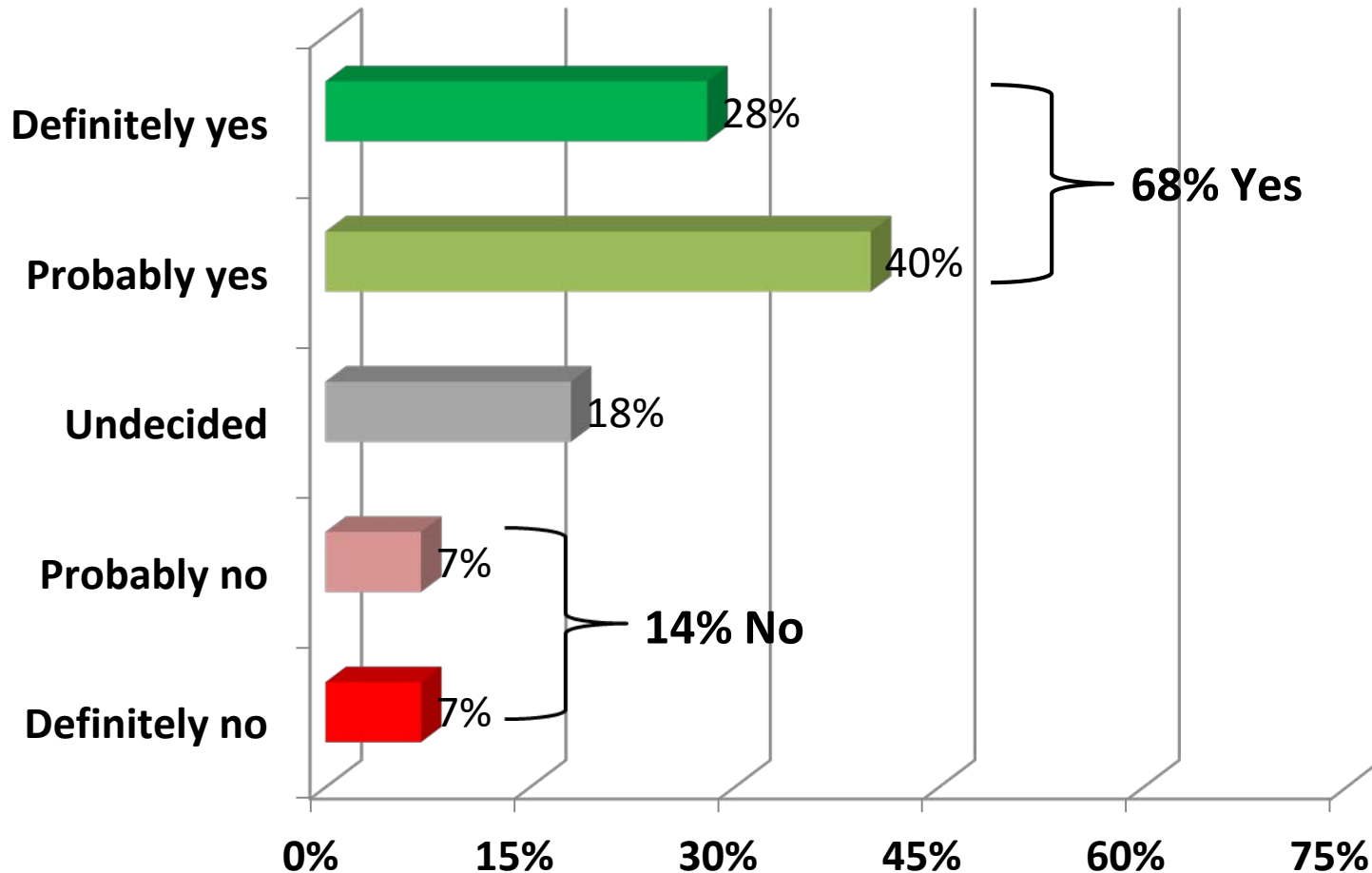

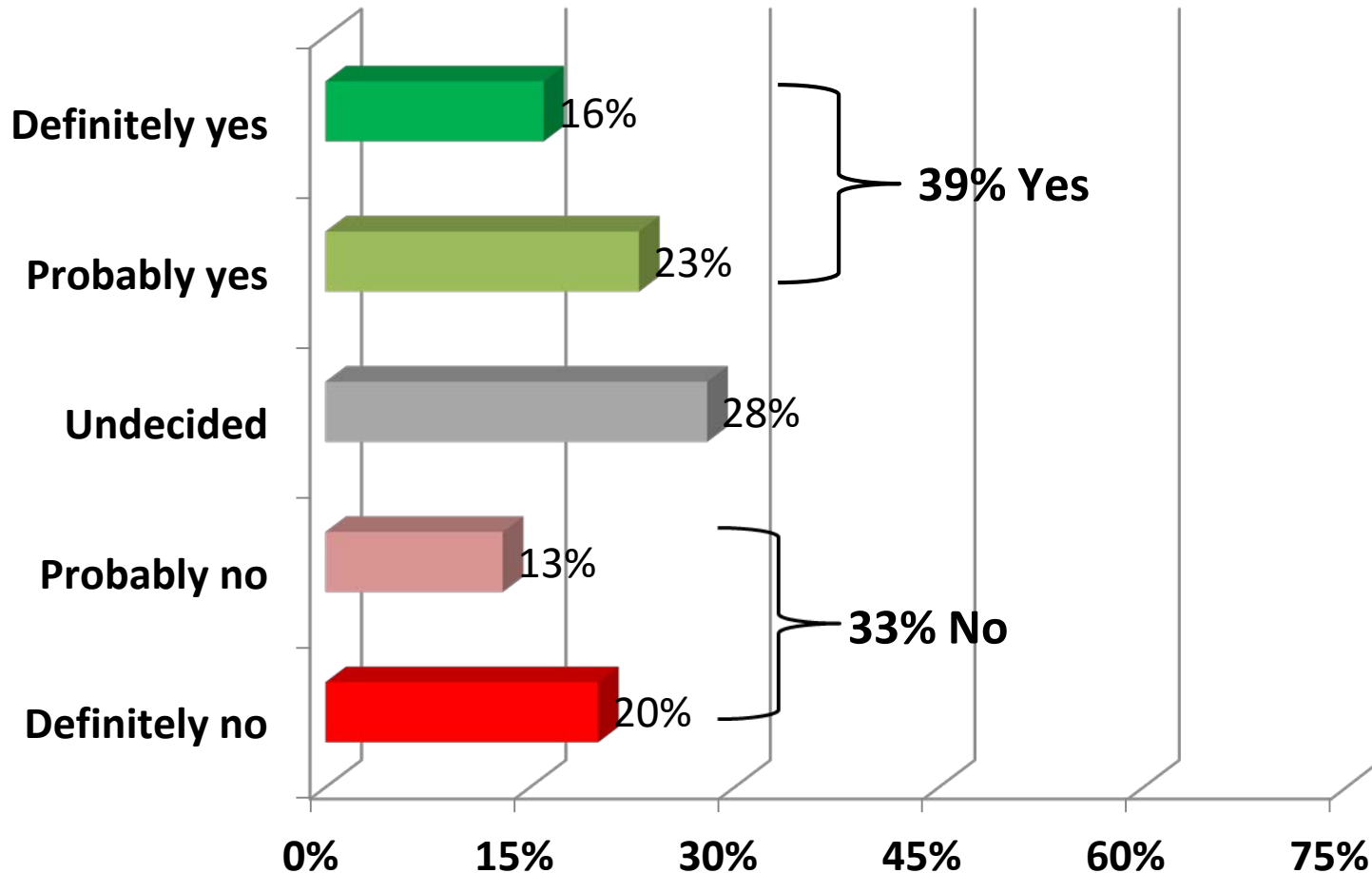
