Substitute Teacher Training

Description

Wisconsin school districts are in need of, and want to hire and retain qualified substitute teachers. Wisconsin PI 34 enacted a rule allowing school districts to hire non-certified teacher substitutes. To be issued a three-year, short term, substitute teacher permit individuals must hold a (four year) Bachelor's degree, receive appropriate training, and be sponsored by a school district. Our training will teach and engage prospective substitute teachers in activities that mirror real classroom situations. Our instructor will model a variety of teaching strategies that substitute teachers can use in the classroom. Additionally, participants will gain a deeper understanding of effective teaching principles in order to prepare for future substitute teaching assignments.

- * Introduction to substitute teaching
- * Practical tips and guidelines for being effective in the classroom
- * Classroom management / PBIS
- * Important safety and health information
- * Age-appropriate instructional strategies
- * Special Education
- * Sample lesson plans
- * Substitute teacher permit application process

Who should attend?

Individuals who hold a (four year) Bachelor's degree (or higher) from an accredited college or university. Training is geared to those NEW to Substitute Teaching and/or those interested in growing their skills as a Substitute Teacher.
